## Administrative Information

### Provenance

The papers of Bronson M. Cutting, publisher and United States senator from New Mexico, were given to the Library of Congress in 1937 by Alice R.G. Woolbert. Papers were also deposited in the Library of Congress in 1938 by his mother, Olivia Cutting. In 1939-1940, three groups of papers were withdrawn for the use of a biographer; in 1950, all or more most of the material was returned to the Library. The literary heirs, Justine B. Ward, Olivia James, and the Marchesa Iris Origo, converted the deposit to a gift in 1954. Additional material was given by Justine B. Ward in 1959.

## Processing History

The Cutting Papers were processed in 1955. The finding aid was revised in 2010.

## Copyright Status

Copyright in the unpublished writings of Bronson M. Cutting in these papers and in other collections of papers in the custody of the Library of Congress has been dedicated to the public.

## Access and Restrictions

The Cutting Papers are open to research. Researchers are advised to contact the Manuscript Reading Room prior to visiting. Many collections are stored off-site and advance notice is needed to retrieve these items for research use.

## Scope and Content Note

The papers of Bronson Murray Cutting (1888-1935) span the years 1890-1950, with the bulk from 1910 to 1935. The collection consists of personal correspondence, some of it extending beyond his lifetime; correspondence relating to Cutting's activities in New Mexico from 1910-1928, including material relating to his publishing activities; and his investigation of corruption in the state. Also in the papers are correspondence and general files accumulated during his service in Washington, D.C., as senator from New Mexico, 1928-1935. Much of the senatorial material relates to banking, congressional campaigns and an election dispute with Dennis Chavez, veterans' claims cases, constituent affairs, and other legislative issues. Included also are biographical files and printed material focusing on Cutting's political career.
